# **Rapid Testing Solutions for Industrial Chemicals**

Industrial chemicals can pose serious risks to human health, potentially causing acute and chronic health effects, including respiratory issues, neurological damage, and increased cancer risk. Our test kits allow testing to be performed in on-site facilities.



Dioxins/Furans: Polychlorinated dibenzo-p-dioxins (PCDDs) and polychlorinated dibenzofurans (PCDFs) are highly toxic having been linked to cancer, liver damage, and various reproductive and developmental diseases. Traditional GC-HRMS analysis of PCDDs and PCDFs requires extensive sample clean-up and expensive instrumentation, limiting the number of samples that can be analyzed in a timely, cost-effective manner. ABRAXIS<sup>®</sup> Dioxin/Furan ELISA offers improved cost, sensitivity and sample throughput.



PCBs, Higher Chlorinated: Polychlorinated biphenyls (PCBs) are chemically inert and heat-stable synthetic industrial compounds that persist in the environment for long periods of time. Although illegal now, PCBs were produced in the past and marketed under various trade names (Aroclors<sup>®</sup>, Kaneclors<sup>®</sup>, etc.), for use as dielectric fluids in capacitors and transformers, heat transfer fluids, hydraulic fluids, and lubricating and cutting oils.



**Phthalates:** Phthalates are a group of compounds, which are used to increase flexibility and durability in plastics. These functional qualities have made Phthalates useful for a wide variety of purposes and resulted in their inclusion in products ranging from building materials to personal care products and pharmaceuticals.
